Additions to Specifications:

- 1) Prospective offerors may attend an additional opportunity to view the site on **Tuesday, February 19, 2019 from 10:00 a.m. to 12:00 noon**. Attendees shall arrive at the Palo Duro Canyon State Park entrance by 9:45 a.m. and alert the gate staff they are there to view the construction area for the Water Treatment Plant project. From admission at the gate, attendees should proceed to the Mack Dick Pavilion parking area.

Limitations on this visit apply as follows:

- Hours for the visit are strictly limited to 10:00 a.m. to 12:00 noon, without exception.
- No other times or visit dates will be scheduled during the pre-proposal period. This is the last opportunity to view the site before submitting a proposal.
- During this visit opportunity, there will be no technical or administrative presentations, and no question/answer sessions with the project team.
- Drone photography may be permitted for the purpose of viewing areas with limited access by vehicle or foot. However, attendees shall be aware that wind and other weather conditions on the day of the visit may prohibit the use of drones, pose risk to equipment, and impact quality of any photography obtained.

- 2) Specification Section 02 30 00-1, paragraph 2.01A indicates that a geotechnical report for the project is available for review at the CP&Y office.
